- Teams MUST tag their big fish before weigh-in; untagged fish are not eligible for Big Fish Option
- 80% payback on \$200 of entry fee; Pays 1 place for every 5 boats
- Special prize for First Team Out of the Money
- Goon Fish Option: \$5.00 with 50% payback for 1 place

- Registration: Main Ramp (Jojoba) Parking Lot, begins at 3:00 am
- Tournament Hours: 5:00 am to 11:00 am on Saturday, August 1
- 15 boats per flight; flights return at 15 minute intervals beginning at 11:00 am

- Raffles begin when weigh-in scales close; entrants must be present to win
- 50/50 (Winner/Club) Cash Raffle: \$5.00 for 1 ticket, \$20.00 for 5, \$40.00 for 12
- Prize Raffle: \$5 for 1 ticket, \$20 for 5 tickets, \$50 for 15 tickets

- All MBC Tournament Rules apply to this tournament, including off-limits boundaries
- Lake is off limits after 5:00 pm Friday before tournament date
- 5 Fish Limit – 13” minimum (mouth closed, tail pinched)
- No live bait, trolling, alcohol or illegal drugs during tournament
- Boat must have working live well and kill switch
- Life jackets must be worn and kill switch must be attached while big motor is in gear
- A 1 lb penalty will be imposed for each dead fish; short fish will not be weighed
